

## Conditions of participation

### Declaration

The organiser of this competition is Diamant Fahrradwerke GmbH. By participating in the competition, the participant agrees to the following conditions of participation.

### Start, procedure and end of the competition

Participation in the competition is only possible from **30.4.2026 to 31.8.2026**. Entries received after 31.8.2026 will not be considered. We reserve the right to cancel the competition at any time without prior notice and without giving reasons. This applies if there are reasons that would disrupt or prevent the competition from running as planned.

### Participation

Participants must complete and submit the competition form on this page after playing the game PULSE CHATCHER. This requires at least 500 points in the game, personal contact details, apparel size, and an email address, which participants must fill in directly on this website and in the form.

Participation in the competition is free of charge.

### Eligible participants

Natural persons who are resident in Germany, Austria, Switzerland, Poland, Belgium, the Netherlands, the UK, Ireland, Finland, Sweden or Denmark and who have already reached the age of 18 are eligible to participate. No customer relationship with Diamant is required for participation. Legal representatives must give their consent if a participant has limited legal capacity.

Employees of Trek Bicycle Corporation and its subsidiaries and their immediate family members are not eligible to participate. We reserve the right to exclude participants from participation for legitimate reasons.
